

John Fluevog Shoe Giveaway

OFFICIAL CONTEST RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **General.** The Citadel Theatre's "John Fluevog Shoe Giveaway" ("Contest") is sponsored by The Citadel Theatre 9828 101 A Ave NW Edmonton, AB T5J 3C6 ("Sponsor"). No purchase necessary. A purchase will not increase your chances of winning. The "John Fluevog Shoe Giveaway" begins on February 22, 2025 at 5:00PM (MST) and runs until March 23, 2025 at 11:59PM (MST). All entries must be received by this deadline. All monetary amounts herein are calculated in CDN dollars.

2. **Eligibility.** To enter and be eligible to win, a person must be a resident of Canada and over the age of majority in his/her province/territory of residence. Employees of Sponsor, and Sponsor's parent and affiliate companies, representatives and agents, as well as family members and the persons with whom they are domiciled are not eligible to enter this Contest. In the event that Sponsor receives more than one (1) entry per valid email address during the Entry Period, Sponsor will void and destroy duplicate entries and that entrant will be disqualified from the Contest. The Contest is subject to these Official Rules and to all applicable federal and provincial laws. By entering the Contest, participants (and their respective legal guardians or parents, where applicable) agree to be bound by and accept the terms and conditions of these official rules.

3. **Entry Period.** The entry period ("Entry Period") will begin at approximately 5:00PM Mountain Standard Time ("MST") on Saturday, February 22, 2025 and will end on March 23, 2025 at 11:59PM MST.

By entering the contest, the entrant consents to the release of his/her name. The entrant declares to have complied with the Official Rules. Further, the winner must conform to all directions given by the Contest organizers or his/her participation in the Contest will be denied.

Limit one (1) entry per unique e-mail address. Automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. All entries must be received and recorded during the Entry Period to be eligible for the drawing. Entries that contain typographical errors, are

altered, tampered with, incomplete, inaccurate, irregular in any way, or otherwise not in compliance with the Rules, shall also be disqualified.

The drawing will be conducted by Sponsor or Sponsor's representative at approximately 12:00pm MST on Tuesday, March 25, 2025 at the Sponsor's office. The potential winners of the Prize will be notified by email address. If a potential winner cannot be reached within five (5) business days of the first notification attempt, that potential winner will be disqualified and an alternate potential winner will be selected from the remaining eligible entries. If the potential winner is found to be ineligible, does not or cannot comply with these Official Rules, or if the Prize notification is returned as undeliverable, the potential winner will be disqualified and an alternate potential winner will be selected.

Before being declared a winner, a selected entrant must correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question administered by Sponsor.
